Beneficial Substances Uniform Bill

- > AAPFCO's Beneficial Substances Uniform Bill
 - Encompasses definitions for beneficial substances, plant biostimulants, and establishes labeling standards
 - Goal is to bring standardization and uniformity to all US states and Canada
 - Voted Official by AAPFCO in February 2024!
 Unanimous vote by the states

AAPFCO Beneficial Substances Definition

"Beneficial Substance" means any substance or compound, other than primary, secondary, and micronutrients, and excluding pesticides, that can be demonstrated by scientific research to be beneficial to one or more species of plants, soil or media. A beneficial substance includes, but is not limited to, plant biostimulants.

AAPFCO Plant Biostimulant Definition:

"Plant Biostimulant" means a substance or microorganism, or mixtures thereof, that, when applied to seeds, plants, the rhizosphere, soil, or other growth media, act to support a plant's natural nutrition processes independently of the biostimulant's nutrient content. The plant biostimulant thereby improves nutrient availability, uptake, or use efficiency, tolerance to abiotic stress, and consequent growth, development, quality, or yield.
